**RESERVATION FOR SC/ST:**


Department of Personnel & Training, Govt. of India, have clarified vide OM No. 36012172002 Estt(Res.) dated 06<sup>th</sup> November 2003 that after introduction of Post based Reservation, it is not permissible to fill up the post, reserved for ST by a SC candidate or vice-versa by exchange of reservation between SC/ST categories.

In view of the above, it is brought to the attention of all concerned that no exchange of vacancies is allowed between SC & ST categories even if no eligible candidate is available under either of the above two categories. Hence, panel will be drawn keeping in view the above amendment in our subject notice.
